Where We Started

Women Helping Women began in 1999 as a heartfelt response to the growing need for mental health services for women and the desire to break the stigma surrounding mental health. The inaugural luncheon was held in a conference room at the Methodist Conference Center, bringing together fewer than 100 compassionate individuals determined to make a difference. Over the years, the event grew steadily, hosted in local halls and ballrooms to accommodate increasing interest and support.

Since 1999, this event has raised over **\$2.5 million** to transform lives in our community!

Where We Are Now

Now in its 27th year, the Women Helping Women Luncheon is expected to welcome nearly 600 guests, all united in support of accessible, high-quality mental health care for women, children, and families in our community. This event celebrates the power of awareness, advocacy, and communitydriven impact. To accommodate our audience and future growth, we have moved the luncheon to the Meadows Events Center at Prairie Meadows, where we have room to expand and continue fostering meaningful connections and support for our mission.

Established in 1972, Mind & Spirit Counseling Center has grown into one of the largest counseling groups in central lowa, impacting tens of thousands of lives over its 50-year history. Originally founded as Des Moines Pastoral Counseling Center and an extension of the ministry of First United Methodist Church in Des Moines, the Center has evolved into an independent, not-forprofit, community-based organization with no formal affiliation to any faith group or organization.



Over the years, the Center has expanded its services, staffing, and facilities to meet the changing needs of the community. What has remained constant is our unwavering commitment of walking with people through counseling and education to find hope and healing, and to live a fulfilling life. Mind & Spirit Counseling Center continues to be a welcoming place for individuals from all walks of life, providing inspiration, hope, and healing of body, mind, and spirit.
